Annual Report 1999-2000

National Executive Director Denys Correll This has been a year of high achievement for Council on the Ageing (Australia). We saw the end of the International Year of Older Persons and the very successful Australian Coalition 99. It is accurate to say that no where else in the world was such a high degree of cooperation achieved between non-government organisations, and between non-government organisations and Government.

A survey undertaken by the Government at the beginning of 2000 found that 85% of people surveyed were aware that 1999 had been the International Year of Older Persons compared with 16% in 1998. Other results of the survey showed very positive attitudes to older people.

Council on the Ageing (Australia) began preparations for the International Year as long ago as 1995. We used the model of the International Year of Disabled Persons that many people remember as the most successful International Year. Australian Coalition 99 was modelled on the American Association of Retired Persons initiative for the year. Council on the Ageing (Australia) was fortunate to receive early recognition by the Commonwealth Government for the initiative to establish Australian Coalition '99.

The many achievements of the Year and Australian Coalition '99 are documented in the Commemorative Journal produced at the wind up of Australian Coalition '99.

Council on the Ageing (Australia) conducted its first national congress in 1999. The congress, hosted by Council on the Ageing (South Australia) was an outstanding success. It was the first major meeting in Australia on the subject of Mature Age Employment. The media interest was extensive and, what is more, this interest has been maintained ever since.

Council on the Ageing (Australia) is a national leader in mature age employment issues and this has been recognised by external organisations including the Committee for Economic Development of Australia (CEDA). Council on the Ageing (Australia)'s Deputy National Executive Director addressed a conference of CEDA on mature age employment issues. As a result, Ms Sheen was invited by the Committee for Economic Development, USA, to be the only Australian speaker at their Conference, *The Ageing of the Global Workforce*.

Mature age employment has been the subject of a major inquiry by the House of Representatives Standing Committee on Employment, Education and Workplace Relations. The Committee's report reflects many of COTA's recommendations. We know that major structural and

attitudinal changes are needed before we have a society that fully appreciates the social and economic reasons for mature age employment.

The Government's tax reform has engaged much of our policy resources over the last two years. COTA recognised on the release of the tax reform package that pensioners and selffunded retirees were not sufficiently protected in the reforms. Through COTA's approach to Government, significant modifications to the proposal were made. These included more adequate indexing of the pension, and the extension of selffunded retiree's supplementary bonus to retirees aged 55 and over. On this last matter, the Office of the Minister for Social Security said in a letter advising COTA of the improvements, "I am pleased to be able to advise you that the minimum age limit for eligibility to the Self-Funded Retirees Supplementary Bonus has been reduced to age 55. This is in line with the suggestion in your letter." COTA through its endeavours has improved the taxation package for millions of older Australians.

The changing face of residential care has been a challenge to the whole society. The events at the Riverside Nursing Home have ensured that residential care cannot be the same again in the eyes of the community. The aged care reforms of 1996 put in train major structural changes that have impacted on residents and families. Accreditation is underway and as a result of Riverside, the complaints scheme has been revamped. COTA continues to represent the interests of older Australians. The President Sheila Rimmer is a member of the Minister's Aged Care Issues Forum and advocates very strongly for older people.

Projects related to COTA's goals are a key part of our activities. COTAs throughout Australia are conducting the Be Wise with Medicine Project — Being in Control: Older People and their Medicines. The project is being conducted as a business/community partnership with the Pharmacy Guild of Australia. It is an exciting endeavour as we are reaching into the lives of so many people throughout the whole country.

Last year, COTA as the publisher of the Australasian Journal on Ageing, revamped the Journal. COTA publishes the Journal as a partnership with the Australian Association of Gerontology, Aged and Community Services Australia and the Australian Society for Geriatric Medicine. This joint venture has resulted in the Journal going from strength to strength. According to our calculations, on a per capita basis, it is the highest circulation journal on ageing in the English speaking world.

In addition to the Australasian Journal on Ageing, COTA publishes ReportAge and Strategic Ageing. The latter provides in-depth analysis of ageing issues.

COTA believes that to create a better society for older people, we need to keep in contact with the wider world. COTA through its membership of the International Federation on Ageing is co-hosting with the Western Australian Office of Seniors Interests the 6th Global Conference on Ageing in Perth in 2002.

There is much more that can be said about the work and success of the Council. In this report I have only attempted to relay the highlights.

President's Report

It gives me much pleasure to present to you the Annual Report for the year 2000. The high level of almost feverish activity preceding and during the International Year of Older Persons has subsided; but it is very pleasing to participate in and observe the ongoing activities and projects generated during 1999.

During this last year I have endeavoured to develop closer relationships with our very diverse and dynamic COTAs throughout Queensland. One of the highlights of the year was the visit by the Executive Director and myself to Cairns for the formation of the Cairns and District Committee on Ageing. On the following day we met with members of the Townsville Region and the Dalrymple–Charters Towers COTAs. These opportunities which have usually been fairly rare are much appreciated by all concerned. The communication with our rural and remote members especially in the north and the far west has been enhanced by improvements to COTA Q's web site and by the use of electronic bulletins to a growing number of COTA's who are connected to internet.

COTA Q is involved in a number of projects at a national and state level, which are covered in other sections of this report. I must however commend Melissa Bailey on both the quantity and quality of her work with older people involved with the Safe and Confident Living project. A special mention must go to the work she is doing with new and emerging communities.

The three monthly forums of COTA electorates have provided excellent opportunities for interaction and information sharing. The Annual State Forum, which was held at Kingston in 1999, gave delegates from regional and rural areas a similar opportunity. The Gold Coast Committee on Ageing will host the 6th Annual State Forum in November this year. The work done by the Committee and the support given by the Gold Coast City Council is much appreciated. The 2nd Biennial COTA Q State Conference will follow the 6th State Forum.

My own involvement in National COTA activities has meant frequent absences from Brisbane during the past several months. One of these activities has been a national strategic planning review to be completed before the National Annual General Meeting in November. COTA's in all the states and territories are involved in this review.

No annual report would be complete without mention of The Festival of Music and Song, which was once again a wonderful performance, and I congratulate Luke Harriman, the producer. He had the large shoes of Vera Evans OAM the long time organizer of this event to try and fill.

The computer classes for older people which are ably conducted and coordinated by volunteer Alan Rawlings and staff member Tony Riviera have been an outstanding success. Computers for the Mortally Terrified has drawn people who may have hesitated to join other less specific beginner's classes.

Board members and the Executive Director represent COTA Q and our constituents on a number of Committees and District Health Councils. Those Board members from Maryborough, Noosa, Bribie Island and the Gold Coast have made a valuable contribution in regional representation. I would also like to pay tribute to the efforts of Jack Penberthy, Josephine Smyth, Maggie Crowe and Anne Miller who have left the Board this year.

For the work undertaken in preparation for – and throughout – International Year of Older Persons 1999, my thanks go to Josephine Smyth, Chair of the Australian Coalition '99–Qld and to the members of the AC'99–Qld State Coordinating Committee who represented twelve state-focused older persons organizations. COTA Q records also its appreciation to the major community sponsors of AC'99–Qld: Forest Place Retirement Villages and The Sunday Mail, and to the minor sponsors including the ACTU, EK Williams Printers, CMRS Computer Solutions and RetireInvest.

COTA Q acknowledges other project funding support provided by the Queensland Department of Health, The Commonwealth Department of Health and Aged Care, and the Queensland Department of Families Youth and Community Care.

Like all community organisations we could not exist without volunteers who give so generously of their time and skills.

My grateful thanks to my Board colleagues who have given me support and encouragement throughout the year. On behalf of the Board our appreciation to Wendy Skitch the Executive Director and her staff who always seem to manage the extra mile and still remain cheerful and always helpful. The Board appreciates your loyalty and commitment.

Executive Director's Report

Introduction

This Annual Report documents a hectic year. During the last half of International Year of Older Persons (IYOP), COTA Q was faced with heavy demands for representation and support without increased financial resources. The Board, members, paid staff and volunteers all worked together to do what had to be done and to ensure that all opportunities to promote positive ageing were maximised.

IYOP work continued well into year 2000, which brought with it the need to reduce office space and make some radical changes in staffing. Having initiated changes in computerised systems to address the foreshadowed Y2K problem, preparation for the introduction of GST was undertaken. Registrations have been completed successfully. A new accounting system has been installed and customised.

Also in year 2000, two new projects were initiated: a smaller one that enabled us sustain a focus on cultural diversity, and a larger one, the national "Being in Control: Older People and their Medicines" project that is reported fully on page 18.

Initial planning was undertaken for the holding of the 6th Annual State Forum of Committees on the Ageing and the 2nd Biennial COTA Q State Conference, both to be held on the Gold Coast in November 2000.

Governance

Meetings of the Board were held usually monthly. Representation included members from Bribie Island, Gold Coast and from Maryborough Districts. The Finance Committee has met monthly and reported to the Board.

Membership

Lists of current financial members are published with this Report. Again a number of seniors' clubs closed this year. New organizations of seniors were recruited to membership, resulting in a net loss of one. In 1999-2000 the number of individual financial members has increased by 7.2%.

Organisational Management Office of COTA Q

In 1999 additional office space was leased, principally — but not only — to accommodate AC'99–Qld and the additional meetings generated by IYOP. However, this was terminated in January 2000 due to financial constraints. Until February 2000 the office provided support to the Secretariat of AC'99-Qld. A Computer Training room had been established upstairs. This has been relocated in the downstairs premises, and other office space compacted.

In July 1999 when funding was awarded by Families Youth and Community Care to Lifeline to establish Seniors Enquiry Line, the part subsidy to COTA Q Seniors Infolink initiative ceased. This resulted in some restructuring within COTA. We have established a good working relationship with the new service and refer callers wherever possible. This is reflected in the following analysis of recorded contacts:

Committees on the Ageing

Further outreach has been undertaken over the past year, and this is covered in the President's Report. In line with the plan for Committees on the Ageing, nine individual committees in the past year have formally become Chapters of Council on the Ageing Queensland. Most others are part way through the process.

At the forthcoming 6th Annual State Forum of Committees on the Ageing, to be held on the Gold Coast on 2 November, time is to be devoted to strategic planning. This will ensure that this Council and the Committees on the Ageing synergise. Issues such as communication and communication strategies will be high on the agenda.

Executive Director's Report continued

This year COTA Q commenced regular despatches via an Internet Bulletin to Committees on the Ageing. Feedback has been positive. The COTA Internet Bulletin is here to stay.

Festival of Music and Song — 2000

This is an annual event for all seniors. The Festival attracted a smaller audience than last year, possibly due to a marked increase in admission cost. This increase was due, in part to GST. This year the Concert was produced by Mr Luke Harriman and compered by Mr Royce Perkins. The Australian Army Band was a focal point. New artists were included and feedback from the audience has been excellent.

Next year the Festival is to be moved from July to October. It will be held on Tuesday 2nd October 2001 and, once again, fall within Seniors Week.

Conclusion

Highlights in 1999-2000 included the 5th COTA Q State Forum of Committees on the Ageing in Kingston, and the final event for AC'99 Qld the Partners Recognition Morning, hosted in the Parliamentary Annexe by the Hon Anna Bligh MLA, Minister for Families, Youth and Community Care. This was a splendid finale, recognising the contribution of two hundred and forty-nine separate organizations across the State to plan and to provide community input and focus into what was International Year of Older Persons 1999.

A number of new challenges have arisen from our work this year. The whole area of crime and older persons, the importance of safe communities, the building of those communities and networks deserve ongoing attention. The needs of new and emerging culturally diverse communities and the particular very basic needs of their elders was highlighted. Increased acceptance of COTA within the aboriginal and islander community of Brisbane North has brought with it challenges and opportunities.

It is clear that COTA Q, within its role as a peak consumer organization, should provide support and management resources/skills to consumers and carers in these groups, so that they can access basic services, can participate in their planning and development, and articulate their own views and interests.

Meetings of the Seniors Surfers User Group are held on the first Tuesday of each month at COTA Q. In January 2000, COTA Q surrendered the lease of the first floor training/meeting rooms, due to financial constraints. Space is now at a premium; however, the User Group with changing faces and places, remains just able to fit into the computer training room. Alan Rawlings prepares a Senior Surfers Newsletter monthly and this is sent to interested members of the Group.

The Senior Surfers group and the computer classes have been visited by a number of academics and others who wish to draw on the experience of the group and to document the adjustment of older persons to computer and Internet technology.

Internet for Seniors — a Train the Trainer Computer Module

This training module, made possible through a grant from the Gaming Machine Community Benefit Fund, has been in use for over a year. It has proven to be a highly effective training tool.

Computers for the Mortally Terrified — name coined from COTA WA

This course has developed to address the training needs of the very beginner. It is exceptionally popular and all classes are fully booked.

Basic Microsoft Word 7 - designed within COTA WA

Senior Surfers conducted a one-off pilot course with a trial group of four people. It proved to meet the needs of the participants, with only a few adjustments. Until we have time to negotiate with COTA WA the running of this course, it will remain on hold.

Members and graduates from the classes are able to use the six computers in the training room outside class hours. It is pleasing to note that an informal 'buddy' program is emerging, with several more experienced seniors giving extra time after class to work beside others and coach them along. This certainly adds to the instruction given by the Compumentor.

On an average we receive two calls a day about computers and computer training.

The Brisbane Inner Suburbs Safe and Confident Living Project (S&CL Project) commenced in August 1998. This three (3) year Project is funded through the Older Persons Action Program, Office of Ageing, Families, Youth and Community Care Queensland.

The Community Worker/Safety Link Advisor has worked with older people within their local communities and with community organizations within those local communities engaging them in activities that

- provide accurate information about vulnerability to crime;
- provide information about crime prevention strategies to older people;
- link older people to existing support networks and services; and
- facilitate inter-agency cooperation to address the impact of crime and fear of crime among older people.

COTA Q believes that peer education is an effective method of disseminating information to substantial numbers of older people. A peer education model has been used to further enhance this project and to enable it to address its wide geographic spread. Ten (10) older volunteers have undertaken training sessions and engaged in peer-to-peer education.

Being in Control: Older People and their Medicines

The project has been funded by the Federal Department of Health & Aged Care, under the International Year of Older Persons grant scheme, and is a joint project of the Council on the Ageing and the Pharmacy Guild of Australia. The project commenced in June and will conclude in November 2000. The National Coordinator is Sue Hendy, of COTA Vic, and the National Resource Officer is Jan Donovan, who was instrumental in the delivery of a similar project in 1996.

The Aim of the project is to empower older people to manage their medications. The two key themes are:

- Ask and be wise with medicines, and
- Manage your medicines don't let them manage you.

The role of the Peer Educators is to provide information about the issues of medication management and to encourage older people to be assertive with their doctors and pharmacists.

Peer Education has proven to be a very successful strategy for adult education. The learners can relate to the Peer Educator in ways that are different than with an educator of a different age and experience.

A total of 25 Peer Educators have participated in the two day training courses which were held in Brisbane, Barcaldine, Townsville and Cairns. Two Peer Educators have Non English speaking backgrounds and three are from indigenous communities. Michelle Bou-Samra a pharmacist from the Gold Coast is the Guild Pharmacist for Queensland and assisted with each of the Brisbane sessions. In each centre where training took place a Guild Pharmacist participated.

Each of the Peer Educators has undertaken to do four presentations to groups of Seniors in their area. A number of these have taken place at Seniors' Centres, Retirement Villages, Respite Centres where Carers have been included and Alzhiemers' Support groups. The National goal is to reach over 10,000 older people.

Project milestones at this point have been satisfactorily completed. The final evaluation will take place in November.
